



## Request for Proposals for CDL program Tractor / Trailer

Fort Scott Community College is requesting proposals toward the purchase of four tractors and three trailers for our commercial driver's license (CDL) training program.

- Tractor 1 – would meet the following minimum requirements:
  - 2020 or older
  - Day cab or sleeper cab
  - Single or tandem axle
  - Standard or auto shift transmission
  - Less than 500,000 miles on engine and transmission
  - Clean DOT inspection, including tires
  - Cost should not exceed \$67,500
- Tractor 2 – would meet the following minimum requirements:
  - 2020 or older
  - Day cab or sleeper cab
  - Single or tandem axle
  - Standard or auto shift transmission
  - Less than 500,000 miles on engine and transmission
  - Clean DOT inspection, including tires
  - Cost of truck should not exceed \$67,500
- Tractor 3 – would meet the following minimum requirements:
  - 2020 or older
  - Day cab or sleeper cab
  - Single or tandem axle
  - Standard or auto shift transmission
  - Less than 500,000 miles on engine and transmission
  - Clean DOT inspection, including tires
  - Cost should not exceed \$67,500
- Tractor 4 – would meet the following minimum requirements:
  - 2020 or older
  - Day cab or sleeper cab
  - Single or tandem axle
  - Standard or auto shift transmission
  - Less than 500,000 miles on engine and transmission
  - Clean DOT inspection, including tires
  - Cost should not exceed \$67,500

- Trailer 1 – Flatbed trailer – would meet the following minimum requirements
  - 45 to 48 feet long
  - Drop deck w/beaver tail and ramps
  - Tandem axle
  - Clean DOT inspection, including tires
  - Cost should not exceed \$45,000
- Trailer 2 – Dry van – would meet the following minimum requirements
  - 28 feet long
  - Tandem axle dolly
  - Clean DOT inspection, including tires
  - Cost should not exceed \$35,000
- Trailer 3 – Dry tandem – would meet the following minimum requirements
  - 48-53 feet long
  - Tandem axle
  - Clean DOT inspection, including tires
  - Cost should not exceed \$35,000
