The following documents must be on file with the FSCC International Student Coordinator before the Immigration and Naturalization Form No. 20 (I-20) can be completed, signed, and issued. Without the I-20, an international student cannot attend a college in the United States.

- Submission of the admission application (fortscott.edu/InternationalApplication)
- \$50 non-refundable admission application fee (call our cashier to pay at (620) 223-2700 ext. 5090)
- Secondary school transcript (sent directly from school to FSCC must also include certified evaluation, translation if not in English, and include a graduation date)
- College transcripts (sent directly from school to FSCC must also include certified evaluation and translation if not in English)
- Proof of medical insurance (including repatriation coverage)
- Proof of secured housing
- Copy of passport
- Proof of full COVID-19 Vaccination (if mandated by the CDC at time of application)
- Evidence of financial resources in the amount of at least \$13,000.00*
- Tuberculosis test results, test to be done in U.S. immediately upon arrival. Test results required prior to enrollment.
- Down payment of \$1,500.00 USD towards tuition/fees. This down payment would be in addition
 to the nonrefundable \$50.00 application fee and the \$130.00 housing application fee, if
 applicable.
- TOEFL score verification, OR IELTS score verification
 - TOEFL score of 520 (190 computer score, 68 for TOEFL iBT)
 - o IELTS overall score of 6.0 (minimum score of 5.0 in each band of the IELTS. If a lower score is earned in any of the five band scores, the overall score cannot be accepted)
 - Nursing TOEFL iBT scores (Writing 20, Reading 19, Speaking 20, Listening 20)

Dates for completion of the above listed procedures are as follows (no exceptions):

Fall Semester Admission: July 1st
Spring Semester Admission: December 1st
Summer Semester Admission: May 1st
